Requirements is as follows:

The vehicle proposed to be provided should satisfy the following conditions:

- 1. The Vehicle should be of 2022 or recent model and should be in good running condition.
- 2. The vehicle should be quoted for 2000 km per month. The rate quoted should be for the vehicle alone, without Driver and without fuel.
- 3. The rate quoted in respect of the car shall be inclusive of all charges for covering a minimum of 2000 km. per month. Rate for excess km. after covering 2000 km. in a month should also be quoted. The excess km. will be calculated on quarterly basis.
- 4. The periodical maintenance should be undertaken by the Agency / Individual.
- 5. No revision of rate will be entertained during the Contract period.
- 6. The car hired should be made available on holidays also.
- 7. The vehicle should have valid comprehensive Motor Insurance and in the event of accident and repair thereon during the contract period, LMD would pay the additional amount if any, beyond the insurance amount.
- 8. The Contract amount shall be inclusive of GST as applicable from time to time.
- 9. The Legal Metrology Bhavan is located at Pattom, Thiruvananthapuram. However the service of the vehicle shall be required to be provide at any location in Kerala as and when required.
- 10. The owner should provide provision for fixing the name board of Legal Metrology Dept. on the vehicle.
